C24/229 MOTION FROM CLLR T. KING THAT THE COUNCIL SET POLICIES FOR MAINTENANCE OF THE PUBLIC GARDENS AND PUBLIC REALM.

To reduce problems in the public realm associated with plant growth, interested councillors draft a directive for contractors. In summary:

Footpaths, cycle paths and play area foliage, which should be inviting and not intimidating.

Trees near major roads should be pollarded to reduce the likelihood of damage by strong winds and should not mask lamp posts.

Grass should be cut up to hedges, trees and fences yearly to improve appearances and prevent encroachment of briar.

Hedgerows and Woodland should be suitably managed.

Formal gardens and open spaces which have been neglected may be listed by councillors for the attention of the gardening team.

Special funding may be sought for the above.
