The Council **received** a report detailing Citizens Advice Telford & The Wrekin's new outreach model proposal for services to be delivered within the parish under a renewed partnership working agreement. The new outreach model envisages permanently available 'drop-in' confidential spaces with telephone and video conferencing facilities for 'remote' advice sessions.

RESOLVED that the Council confirmed that adoption of the new outreach model was not possible at Hadley Community Centre and that Citizens Advice Telford & The Wrekin should consider other venues, possibly including Hadley Library at Hadley Learning Community, if the new outreach model is the only option for continued delivery of services in Hadley.

022/21 FUNDING REQUEST - APLEY WOOD PRIMARY SCHOOL

The Council **considered** a funding request received from Apley Wood Primary School, to support the purchase of a secure storage and charging cabinet for IT equipment at a cost of £830.00 and replacement of the iPad tablets at a total cost of £7,390.00 (all costs exclusive of VAT).

RESOLVED that the Council will contribute £1,000.00 towards the cost of new IT equipment at Apley Wood Primary School.

023/21 TELFORD INTERFAITH COUNCIL - FUNDING SUPPORT

The Council **received** a **report** on uptake of Telford Interfaith Council's breakfast provision within the parish. During April 711 Breakfast Parcels had been distributed representing 9,954 meals (breakfasts and lunches provided for 7 days to each child) supporting 198 children from 81 individual families. During the same period 243 Emergency Food Parcels were delivered providing 4,009 meals i.e. between 12 and 21 meals per package depending on stock levels. The Chairman informed the Council that Telford Interfaith Council was now also supporting an additional 20 families with children at HLC who were struggling but did not qualify for Income Support.

RESOLVED that the release of £1,000.00 of funding to support continued service provision is approved.

024/21 INTERIM REPORT - FOOD SECURITY WORKING GROUP

The Council **received** a verbal interim report from Councillor J Parkin, leader of the Food Security Working Group, on factors affecting residents' food security. The working group had met 6 times since January and a questionnaire developed for stakeholders. Questionnaire responses had been received from primary schools and HLC, and Telford Interfaith Council although responses were awaited from healthcare providers. Themes were beginning to emerge including difficulty in quantifying the level of food hardship being experienced in the parish, and although the schools' experience was that most emergency need was being addressed there remains a need for 'enabling' provision such as community allotments and gardens, and classes to equip people with the skills to cook from fresh, The Group planned to report to Full Council in July with recommendations for action that could be taken by the Parish Council.

RESOLVED that the report is noted.
