 - o i. Average and 85th percentile vehicle speeds*
 - o ii. Daily and hourly traffic volumes*
 - o iii. Identification of high-risk periods*
 - o iv. Any anomalies or patterns relevant to road safety*
- 5. Will use the findings to evaluate and, if appropriate, propose the implementation of speed-reduction and road safety measures on Hadley Road, Kearton Terrace, Church Street and Pool Meadow.*
